**THIS FORUM** is dedicated to all whose passion for DEMOCRACY is a beacon to neighbors, nations and world humanity.



**On behalf of Philadelphians who are actual or potential consumers of Wade AV products:**

Degrees of Captivity- incarcerated Philadelphians, friends and relatives residing in areas served by the franchise in question authorized by this county in 1983

Female Heads of Households of Philadelphia County

African peopled villages of Philadelphia county

Children and other vulnerable people of Philadelphia county

**This ordinance (Bill No. 1170) does not merit consent of counsel for the following reasons:**

- 1 consent would further downsize the amount of relevant local information available to decent human beings, especially potential public servants in the targeted areas of this franchise;
- 2 consent would decrease the opportunity for neighborhood caring as a lifestyle;
- 3 consent would obscure potential civic leaders from the awareness of their immediate neighbors, and perhaps even from their own self-awareness;
- 4 consent would escalate the neo-imperialism, neo-colonialism, and neo-elitism lately endemic within the urbanculture in the city-county of Philadelphia;
- 5 consent would re-inforce the opportunity for remote decision-makers to unduly influence the knowledge, enforcement, and application of democratic rights, privileges, and opportunities, legally available to citizens of Pennsylvania;
- 6 consent would enhance the local variation of the Washington D.C. political gridlock which is revealing a complex civil war between hostile camps of US citizens at the national socio-economic level;
- 7 Culture, as art, entertainment, history, tradition, and peer standards would be further disoriented if council consents to this ordinance and its implications.
- 8 The African American Urbanculture needs to be a party to, bear record of, and provide corporate infrastructure that would enable our posterity to conceive, produce, design, package, market, distribute, and profit from experiences in our troubled nation as a whole, and within Philadelphia, our house of hostility. Consent to transfer this vital property, while legal, would snatch away a victory from consumers holding vital expectations, grounded in economic partnerships with any corporations permitted to merchandise to them and to their children
- 9 The families struggling to develop as individuals, as persons, and as viable communities, in those areas marketed by the controller of this franchise, are more likely to be further programmed with viciously competitive influences as audio-visual art and entertainment, while they are simultaneously being denied the natural benefits they are entitled to as public owners of these airways.
- 10 Transfer of this television franchise from Wade Communications Partnership would be another signal that this county is ignoring a civil war between the corporate/global information management systems, i.e. major and minor communications industries, and the developing (and would-be self-controlled) Africanesque Villages of our USA urbanculture in Philadelphia.

The following commentary about the above conclusions as to the undesirability of proceeding with the proposed agreements in the matter of Area II cable television franchise now held by Wade Communications Partnership, represents a thirty year study by Mattie L. Humphrey, Founder of the URBAN SELF STUDY INSTITUTE of WISTER, Philadelphia.

**Imperatives:** Information management against the consent of the people in a democracy is an offer, invitation, or perhaps a prelude to tyranny! Information is not merely a matter of public property! It is the basis upon which individuals are enabled to exercise their obligations in a free society. Access to vital information and due notice by direct information are the foundations of consent in all human affairs!

A population misinformed about itself, about the surrounding territory, about the common authority, and about the common codes of behavior is like a poker player who does not know the type of poker he is playing, the character of his fellow-players, and most importantly, the house-rules! Some of these things are written in stone, some of them are what the traffic of the moment will bear!

1. The diversity within the population served by this franchise reflects a community in dynamic phases of civil development. Current corporate media fare trivializes ideals and other audio-visual nutritive elements, in favor of so-called action, mean-spirited, hatred-filled, and fiercely competitive, forces as the dominant values that highlight modern life. Remote corporate decisions based upon this status quo profit by disorienting naive folk.
2. Information for popular consumption, especially the audio-visual variety so popular with corporate commercialism, is packaged on one hand, in images and sounds of discord, anger, hostility, and selfish relationships; and on the other hand, by successful, smiling, media stars with employment security, multiple job opportunities, dynamic career patterns, and multiple choices of fun and leisure for pay. This duality of extremes, while a painful denial of our actual experience as individuals, tends to make us more tolerant of implied inequities; which do in fact thrive because of backward school systems, uninformed electorates, and uncaring corporate decision-making systems.
3. Interactive information, on a lifestyle basis, helps make neighbors neighbors! while Philadelphia is a city of neighborhoods, it is becoming a gridlock of turfs, often with absentee leaders who are "de facto in charge" but legally unobligated to the folk.
4. Imperialism and colonialism, together, focus upon racism as a method of controlling human interactions within selected territories; Philadelphia is such a territory. Major socio-economic interlocking directorates utilize certain corporate privileges, based upon a) legal disputes of record, and b) rules created by court made-law, in order to unfairly compete with natural folk of dignity, good will, and cooperative spirit, who are trying against odds, to build systems of self-service and public policy in neighborhoods.
5. Civil rights in this hostile climate are legally available, but such humble folk seldom have the public policy awareness or the pocketbook flexibility to access available remedies; and so for lack of information critical, battles of this civil war are lost by owners of this great country to owners of state-authorized corporations. Africans are strategically at a unique disadvantage in this bureaucratic marketplace as matters were and are defined.
6. The common denominator of public policy in the county of Philadelphia today is that people as aggrieved individuals, have no rights which corporations, as a privileged class of citizens, are bound to respect. Such rights of record, as ordinary folk arguably have, are often not known to them, and are almost always not affordable on their behalf.

7. Elements of modern arts, crafts, professions, hobbies, skills and trades are presented by corporate media systems as humanities, culture, and financial opportunity. These abstractions as audio-visual scripts, scenarios, science fiction fantasies, photographic special effects, may offer escape from reality. Too often the individual cannot get back personal reality. All too often life in Philadelphia imitates our perceptions of LA.
8. African Americans, and others, who are now served by this franchise hold, against great odds, the expectation that they will live to experience the ownership and pride of economic investment in media systems offering products for their home consumption that are personal, relevant, timely, developmental, and affordable. This promise was a critical part of the original franchise agreement but has not been honored in the exercise thereof to date. To continue this pattern would fail council's sworn duty to represent the vital interests of these folk in matters of safety, education, and civic awareness.
9. Young African American children enter social institutions eager to learn and ready to grow in collective consciousness; however, toward adolescence, our youth receive the distinct message that this nation is polarized to their deficit. Institutional systems promote rhetoric against segregation "because it creates a false sense of inferiority in the African child". However, there is no effort to eliminate the co-essential false sense of superiority in non-African children in that particular context, i.e. early school exposure.
10. This council must a) recognize this civil war of information management and b) re-orient its substance and procedure to represent the best interests of the natural people who are the legitimate owners of this city, this commonwealth, and this great nation!

No further dislocation or transfer of franchise obligations should proceed until a) Philadelphians who are targeted as a marketplace, are able as human beings, to purchase a major portion of ownership, and b) Philadelphia as a municipality, implements the ordinance for public access local origination, programming in each franchise area as provided for in the ordinance of 1983 and upon which promise, members of this target population (as well as other Philadelphians) have depended through several administrations, all under the same political party.

God is our leader: we seek to follow his will and his way.

Creative ideas originating in the chaos and yearning of the African American community are brokered through individual leaders to the mainstream community via corporate contacts; they are then marketed to African Americans through inflated profits which reward the brokers without duly enriching the resource community.

**Platform: Home is Sanctuary for Children; we must re-invent OUR COMMUNITY!**

**Leadership** We must share our best thoughts, our highest ideals, and our human energy.

**Healthy** We must pool resources to balance our goods for our good fortune.

**Neighborhoods**

**Crisis** Healing (among African Americans) and development (among global Africans) must begin and proceed from the inside toward the outside!

**Imperialism** Is incompatible with democracy; self-government is a higher system of law and order than leadership through an individual mortal; therefore, we as a group must inform and direct those we select to exercise authority for us.

**Civil Rights** Are questionable in the presence of civil war: imperialists and other authoritarian leaders appear to uphold the status quo of brute force control.

**Party Politics** Political parties are unable to lead us out of our various degrees of captivity!

**USA Slavery** Persists via socio-economic systems, socio-psychological systems, & socio-behavioral systems; pain and suffering are our common denominators.

**Priority** Some try to get ahead; others try to catch up! Home is abandoned by all!

**Youth** Adults seduce youth through jobs, money, attention; youth need continuity consistency, and relevance of authority that carries certitude and assurance.

**Culture** The lifestyle of Africans in America reflects a new people; it is not a true reflection of Africans on the continent. African American culture needs to become a self-discipline that is recognized, defined, acknowledged, and sustained by the willful inclusion of Africans as a peoplehood, without shunning, rejecting, punishing, and or denouncing individuals merely because they are at a different stage of self-development and self-definition.

Corporate USA and the American public, a media battle for the mind of humanity?

Corporate USA is a world-wide economic system. America as a whole does not control it. Is "the American public" a presumptive reference to all people of the American continent? The European public is not known as the Russian public, the German public, the French public, or the Italian public. Why does USA corporate media refer to the USA population as "American public"? Answer: USA leadership assumes presumptive authority over affairs of this continent!

Some people know that Africa is a continent of many nations, with distinct nationalities, cultural systems, languages, economic systems, and population data. Why then do USA leaders speak of America as if it were the USA alone? Some of us are aware that, prior to colonialism, the people of the African continent had a more natural set of local definitions, nations, languages, and customs a) of inter-relationships, and b) with aliens from outside the African continent.

This American continent is home to population systems which are more natural to this climate, the abundance, the rhythms and seasons of this vast continent including Central America, The Caribbean, and South America. Our indigenous populations welcomed and interacted with the venturesome European and British mercenaries who followed Columbus to these shores and who then proceeded to seize the "free lands" and the spirited people as their economic property in the name of their imperial royalty. The descendents of the indigenous populations exist in limited systems, based upon what colonialist descendants (per corporate continuity) permit them to participate in, such as reservations, tribal culture, limited integration with settlers, gambling casinos, and other specific permissible practices. We all exist in various degrees of captivity!

The American continent was spared the cruel physical violence of the second world war; however the USA was heavily involved in the conduct of that European misadventure (?). The USA corporate system is grounded in European and British economic systems from the days of Columbus. This system, as it pertained to conquered lands, was known as the colonial system. It has undergone many modifications under the pressure of modern technology, i.e. the industrial age, the railroad era, the wireless era, the introduction of radio, telephone, and telegraph, the age of air travel, and now the age of cybernetics. Each of these new thrusts has fundamentally impacted the health of life on earth especially our respective human lifestyles.

Africans, descended from colonial USA socio-economic systems, are mired in an alien mental conditioning, programmed to sustain an alien control over persons, families, and lifestyles. Many thoughtful and mentally energetic Africans, descended from slaves in the USA, have thrown off the alien controls over their person and their lifestyle. In any case, they are not properly applied to everyday decisions in this world, which is reportedly operated by devils, demons, or other bad-guys. There is another popular view that this world is not an orderly system, and that whatever you want you must take from whomever happens to have it. The popular human way is to seize control over the resources you require, maintain that possession by brute force, and remain ready to destroy anyone or anything which appears to threaten your claim to ownership.

Among most popular products in the USA are fun, leisure, games & ridicule!

Technology for mass destruction of humanity is a lucrative business in the USA!

Philadelphians appear numb; they are reluctant to even discuss democracy!

Infanticide attacks liberty here in her cradle!

Mothers Beware!

Prosecution is forever and always, by definition, a tool of civil war!

Corporate warfare against people sets the stage for self destruction of the nation!

Wars by corporations against people are neither religious nor political!

They are fundamentally amoral!

The issue is always greed against need!

Corporate America, controlling the USA free market, has waged a relentless war to reduce the USA Presidency to a Manchurian Candidate Status! General Eisenhower was Stage One. Governor Carter was Stage Two and Governor Clinton is stage Three!

\*\*\*\*\*

"The American People" a rhetorical phrase used to seduce popular culture here and abroad! The Monroe Doctrine implies, to some, that the U S of A would become a model to lead this hemisphere into a culture of nations based freely upon diverse, sovereign republics, with each one facilitating a representative system of self government for its national citizenry! Speculation, to replace the English Channel with the Atlantic Ocean, proved too compelling a temptation for the western establishment to forego a last opportunity to seize technical control over planet earth and the human race!

Corporate free press has invested mega-bucks in a mission to reduce the United States Presidency to a clone, the Manchurian Candidate! It would be unnatural and foolish, for a nation to permit mean spirits to attack it's seminal institutions! Nor would a real nation use such toxic forces to indoctrinate citizens through delusions of grandeur! No, the prosecution against Mr. Clinton, President of the United States, has been waged by the corporate free press of the United States in the name of a fictional people! Media does not speak for people of Philadelphia! Those whose voices dominate the corporate "free" press are not the folk who live with the damaging consequences of public decisions made by those relied upon by the free press for its lies, leaks and legacies!

The USA society has not lived up to principles of our enabling documents, no more than have Christians en masse, lived up to doctrines promoted by officials of Christianity! The "dream" of Dr. King, world renowned Christian American, has become an icon for any selfish, greedy crusader to adapt as rhetorical justification for any

random outcry against public policy. A "dream" has technically become sufficient reason and rationale for anyone to claim personal wants and desires as pivotal public obligations to be respected, tolerated and, in some instances, financed by the general public!

Government is legally obligated to right wrongs done in the name of government, or under cover of public office or via public funds! Government is not so obligated to fund shortfalls that result from personal, optional or sought-after, choices exercised by citizens!

The USA socio-economic policies are rooted firmly in years of colonial style technical legalese! Derivative standards seem designed to facilitate the corporate capacity to tyrannize individual human beings and to "regulate" defenseless families! It is mob rule! It is civil war! It is might pretending to make right! It ridicules right trying to be mighty! It is inversion psychology serving toxic and contagious mean spirits to un-knowing people!

Africans, descended from USA chattel slaves, today embody complex effects of a tangled, overgrown web of western myths, stories and lies, all deeply-rooted in European aggression, colonial strategies, countless civil wars, arrogant lies and historical inequities!

Our USA Presidency, personal embodiment of our national sovereignty, has, in a serial fashion and over these centuries, revealed to the world community the real cost in moral integrity paid daily by we, the progeny of African colonialists! The social imperative that trained us to be who we are blames us for its own fallibility! Bill, Hillary and Chelsea Clinton have invested themselves in service to a troubled, insecure nation! May conscious folk who witness today cease pursuing profits at the expense of other people's humanity!

Major life-styles, advertised as the good life, operate through competition, ridicule, subterfuge, mass destruction, inversion psychology, greed and arrogance! Subliminal clues and guidelines sell as childhood fun, education, recreation and leisure! They are joined by competitive gambling! Popular systems of gambling relate to competition, sports, athletics, and stock markets! Corporate media provides non-stop celebrity shows featuring ridicule, violence, arrogance, greed, and selfishness! US media features audience members rudely denouncing friends, associates, co-workers, strangers, religions, professions, struggles, crusades, fashions, life-styles and other matters reflecting a troubled and suffering public!

People of this continent, and diverse others of the earth, have, for centuries, been misled, even subjugated, by USA policies, allegedly in the name of the American people! Bill Clinton represents citizens reared to believe that intelligence and loyalty are keys to good citizenship. "You are worth your wages, irrespective of your personal faults-of-no-harm, so long as you deliver specified services at advertised cost, according to a contract!"

When Mrs. Clinton raised her sons in mid-America, there were standards of moral integrity in the United States Administration of General Welfare funds! Signals told us Mothers that our children could all aspire to be better than our nation's forbears! We need not be perfect, merely fit a standard of family values and community service at the level of our local community! That USA nation is gone! It left the stage with President Carter!

National moral integrity flowered briefly after the second world war, ending abruptly as post-war greed fired up economic competition over reconstruction and development of war-torn Europe, Russia, Asia and the Pacific! The USA buried policies that had envisioned harmonious development of the American Public as a Continental reality! Our USA Corporate Leadership seems determined to become the New Europe!

A fiction, called "the American Public" covered up a reality of these New States of Europe! These are no more United States of America than the British Commonwealth is a United Kingdom! Nor was the Holy Roman Empire ever more than a legal fiction!

A public system upholding earlier degrees of moral integrity was H.E.W. Public Health, Public Education and Public Welfare were one integrated general welfare system! How does he deviate from the standard of manhood in today's mainstream society? Whose interests are served at whose expense? Who dares believe this society is as good as it's documents?

Laws do not make nations law abiding! Principles merely offer us guidance! Behavior evolves as norms and standards. The moral standard claimed for US society by corporate media is a legal fiction, not a fact! Such a fiction supported Bill Clinton's Mother, may God be pleased with her, and a million of us other mothers, to raise within our sons boundless aspirations to create new standards and to serve a nation-becoming better than her forbears, transcending self-destructive seeds of Euro-Anglo imperialism!
