RE: AGREEMENT WITH WRITERS

DATE: 3 February 1994

The following are the terms of our agreement regarding the article you have been commissioned to write for The World & I.

The World & I (publisher) and author agree that the author will write for the publisher an article as described below:

1. Working title: Media does not cause youth violence
2. Description: Refutation of the view that media contributes to, causes, or exacerbates youth violence
3. Length of article: 4000 words
4. Delivery date: 7 March 1994
5. Month to be published (tentative): June 1994.

The author warrants that this is an original work and that he or she has violated no laws and no person's rights in writing this article and knows of no outstanding copyright restrictions on the work.

The publisher will pay the author as follows:

6. \$600.00 on acceptance of the final work by the publisher.
7. All authorized costs will be paid upon presentation of appropriate documentation by the author at the completion of his or her work. Extraordinary expenses (over \$50.00) must be discussed before they are incurred.
8. If the publisher decides not to publish the work, a kill fee of 20% of the amount in 6 above will be paid to the author. If a manuscript is not scheduled for publication within twelve (12) months following acceptance, the magazine shall, on the author's request, release its rights to the author.

General terms concerning copyrights and reprints: Best form and in its entirety and used form

A. The World & I will hold all copyrights to the article, including: exclusive world rights to publish the article; that is, the exclusive right to publish the article in any format in any language, anywhere in the world and in any publications of The Washington Times Corporation or News World Communications before it is published in any other publications. The magazine holds all rights to grant reprint permission.

B. If the magazine sells reprint rights to any publisher other than one owned by The Washington Times Corporation or News World Communications, it will share those proceeds with the author on a 50-50 basis.



C. The author is welcome to seek publication of the article in other publications provided that permission is obtained and proper credit is given to The World & I as the copyright holder, in which case the article must be credited as such:

This article first appeared in the month, year issue of The World & I and is reprinted with permission from The World & I magazine, a publication of the Washington Times Corporation.

Six months after the magazine first publishes this work, the author may publish the work elsewhere consistent with the terms of this agreement. However, the magazine may thereafter exercise its right to publish the work without further payment to the author.

D. Given time limitations for processing the article, the publisher may exercise the option to do minor editing and publish the article without review by the author. The publisher retains the right to withhold publication of the work, to ask for reasonable revisions, or to publish it in ~~revised~~ form. If the work needs extensive revision, the author has the right ~~to request that his or her byline be removed.~~ with minor revisions slightly revised of approval.

If you agree to these terms, please sign both copies, return** one copy, (retaining one copy for yourself), and this letter will constitute our agreement with each other. We are pleased to be working with you.
